1. **Free Checking:** \$100 minimum opening deposit, no minimum balance requirement. **Interest Checking:** \$500 minimum opening deposit, \$2,500 minimum daily balance to avoid monthly fee. **Interest Plus Checking:** \$500 minimum opening deposit, \$10,000 minimum daily balance to avoid monthly fee.

Money Market: \$2,000 minimum opening deposit and minimum daily balance to avoid monthly fee. Interest rates are variable and may change after account is opened.

2. **Business Checking:** \$500 minimum opening deposit, \$2,000 minimum daily balance to avoid monthly fee. **Business Interest Checking:** \$500 minimum opening deposit, \$5,000 minimum daily balance to avoid monthly fee. **Business Premier Club Checking:** Annual Percentage Yield (APY) is available on account balances up to \$5 million. Any account balance over \$5 million will earn the Business Interest Checking stated rate. The account must maintain a \$20,000 minimum daily balance to avoid monthly fee. On a monthly basis, business must transact at least two (2) remote deposits and five (5) or more electronic Bill Pay withdrawals to qualify for this account type. If the transaction requirements are not met, the account type will be changed to the Business Interest Checking and earn its stated rate. The first three (3) outgoing wire fees per month are waived. Interest rates are variable and may change after the account is opened.

3. Annual Percentage Yields (APY) assume interest remains on deposit until maturity. Certificates of Deposit are subject to early withdrawal penalties which may reduce earnings on the account.
