1. **Free Checking:** \$100 minimum opening deposit, no minimum balance requirement. **Interest Checking:** \$500 minimum opening deposit, \$2,500 minimum daily balance to avoid monthly fee. **Interest Plus Checking:** \$500 minimum opening deposit, \$10,000 minimum daily balance to avoid monthly fee. **Personal Money Market:** \$2,000 minimum opening deposit and minimum daily balance to avoid monthly fee. Interest rates are variable and may change after account is opened.

2. **Business Basics Checking:** \$500 minimum opening deposit, \$2,000 minimum daily balance to avoid monthly fee. **Business Plus Checking:** \$500 minimum opening deposit, \$5,000 minimum daily balance to avoid monthly fee. **Business Premier Club Checking:** \$500 minimum opening deposit, \$20,000 minimum daily balance and on a monthly basis transact at least two (2) remote deposits and five (5) or more electronic withdrawals to avoid monthly fee. Outgoing wire fees are waived for the first three (3) outgoing wires per month. If transaction requirements are not met the account type may be changed to the Business Plus Checking and earn its stated rate. **Business Money Market:** \$5,000 minimum opening deposit and minimum daily balance to avoid monthly fee. Interest rates are variable and may change after account is opened.

3. Annual Percentage Yields (APY) assume interest remains on deposit until maturity. Certificates of Deposit are subject to early withdrawal penalties which may reduce earnings on the account.
